## Aquatic Plant Management Plan Public Meeting

Sara Hatleli is a biologist with Aquatic Plant and Habitat Services (APHS) LLC. APHS is an environmental consulting business that specializes in lake surveys (aquatic plants, aquatic habitats, water quality, and invasive species), aquatic plant management plans, and grant writing. Having an Aquatic Plant Management Plan approved by the DNR is a requirement for getting an AIS Control Grant to help fund our EWM control in the future. A public meeting is required for the plan's approval. The public is encouraged to attend.

# Update from the SOSLA AIS Fundraising Committee

SOSLA has been able to aggressively attack Eurasian Water Milfoil (EWM) the past year because of the generosity of many SOSLA members and others. In all, \$57,095 has been pledged or given from 72 property owners (about 67% of us). In addition, we are grateful for the support from the Town of Stone Lake, Cranberry Festival, Advance Printing, Whistle Punk, Cut in Stone, CJ Landscaping and Rollingwood Nursery. Our experience with EWM the past year has led us to conclude that management of this Aquatic Invasive Species will require diligent monitoring, annual abatement actions, and ongoing expenses to keep Stone Lake a quality resource for all of us.

Thank you everyone who has contributed to this effort so far!

#### Secchi / Chemical Testing Summary -Fall 2024

High winds and considerable rainfall during the early half of the 2024 summer reduced the number of testing days we were able to complete. However when conditions improved, our water clarity readings continued to be excellent. Our maximum depth recorded was 28 feet compared to 27 feet in 2023.

This year we recorded a first with our test samples for phosphorus and chlorophyll. Our early September samples which were sent by priority mail to the state lab in Madison are still in transit as of October 21 according to the official US Postal Service website. Even if the package eventually finds its way to the lab (we suspect it actually was delivered to a dumpster somewhere) we are confident that the preservatives that we use each time we mail our findings will have expired.



Luckily we had two earlier test results this year and they showed very low levels of chlorophyll and phosphorus, consistent with past years.

Recent Stone Lake activity as reported by Craig Roberts includes:

Electro fishing on September 9, 2024 checked for natural reproduction. Three young-of-year walleye and three one-year old walleye were captured. These fish should all be fish that were naturally produced in the lake. In mid-October 4,899 large fingerling walleye (10/acre) were stocked.

#### **Loose Stories about Purple Loosestrife**



Fortunately, disturbing rumors that Lake Avery was "loaded" with purple loosestrife this past spring proved unfounded. The well-meaning people who removed multiple bags of plants from Lake Avery pulled a look alike!

The plants they removed had flowers that were more pink than purple and stems that were round rather than square. I did a thorough inventory of Lake Avery, finding not a single purple loosestrife plant!

Elsewhere on the lakes, purple loosestrife in Big Stone was similar to last year in amount and locations, predominantly the northwest corner of the lake. I removed all of that. I did an inventory of Loosestrife on Little Stone, finding a few plants on the west shore and a lot at the north end, similar to the distribution of Eurasian Milfoil. Now that I am retired, I will have more time to work on loosestrife eradication in Little Stone. I will stay below the high water mark, or in other words, on public property, even though the receding lake levels will make some this dry land. If I need to go above the high water mark, I will contact the property owners for their permission. As always, I would much rather have shore owners police their own property, but I realize not all of us have the time or physical ability to do so.

#### Shore Owners of Stone Lake Association Meeting Minutes – August 17, 2024

President John Ryan called the meeting to order at the Lion's Park with 30 members present

- Introduction and welcome were made for first time attendees
- Update on EWM Cathie-Purchased more buoys and they have been placed. Matt Berg conducted Point Intercept Plant Survey. We had one day of DASH July 8th and four more days August 5-8th. Sarah Hatleli will be conducting a public meeting possibly this fall for our Aquatic Plant Management Plan.
- Guest Speaker Craig Roberts with WIDNR, fish biologist. Craig spoke on the 2023 Stone Lake Comprehensive Fisheries Survey. He explained sampling they did, stocking history of Stone Lake and its results. Also he compared the 2023 Creel Survey with 2010. Fishing pressure is low with walleye and small mouth bass being most pursued. Management recommendation were to continue stocking of walleye, consider protected slot for smallmouth bass, and promote fish habitat with things such as fish sticks.
- Treasurer's report was given. Current Cash 75,000 including CD. CD renewed, \$700 earned in interest to date on CD. AIS unspent \$60,000 Legal unspent \$4,800. Remaining expense for year to come Calendar and last newsletter.
- Membership report given by Dar. Current paid 83
- AIS/Boat Landing-Discussion of possible camera at landing helping enforce decontamination station
- Steve E spoke on Purple Loosestrife. Still here, new growth found in Avery Pond. Has seen some beetle activity.
- Hwy 70 clean up. Need to do fall clean up
- 4th of July boat parade went well good amount of participation. Jan Erickson, Rita Ryan and Susan Boyce organized event.
- Approval of previous minutes.

#### **Regulation of Enhanced Wakes**

There has been considerable activity across Wisconsin this summer with the goal of getting appropriate regulation to reduce environmental and safety impacts of enhanced wakes. Meanwhile wake boats are becoming more powerful and more common.

A new, rapidly growing coalition focused on protecting Wisconsin's lakes was announced in August by five statewide organizations. The founding members of the coalition are the Wisconsin Lakes Association, Wisconsin Wildlife Federation, Lakes At Stake Wisconsin, Last Wilderness Alliance, and Wisconsin's Green Fire. They have since been joined by additional water-protection organizations including the Washburn County Lakes & Rivers Association (WCLRA), anglers, advocates for local control, lake property landowners, sailors, and people concerned with spreading invasive species in ballast water.

The coalition's principles include:

- > 700 ft. from shore Wake-enhanced boating activities should occur at least 700' from any shoreline.
- > 30-ft. depth Wake-enhanced boating activities should occur in water depths of no less than 30'.
- > Prevent the transfer of invasive species in ballast tanks Boats moving from lake to lake must have proof of decontaminated ballast tanks before entering lakes.
- ➤ Local control Local municipalities' existing right to enact and maintain local ordinances that are more restrictive than these state minimums shall be preserved.

One coalition member, the Last Wilderness Alliance (LWA), is assisting Wisconsin towns and their lake organizations with the process of developing local ordinances to regulate enhanced wakes. LWA has developed a standard template that local governments can use to reduce the work involved. Having uniform ordinances around the state avoids the confusion that could be caused by implementation of ordinances with vastly different language. Several towns and lake organizations in Washburn Co. have received assistance from LWA volunteers.

State legislators are also discussing the impacts of enhanced wakes and considering what type of regulations would be most appropriate and effective. It would not be surprising to see new legislation proposed in 2025. But at this time nobody knows what will be proposed or the likelihood of passage.
